RECOMMENDATION:

The Mayor, subject to the approval of the City Council, is recommending the appointment of City resident Ron Jensen to serve as a Planning Commissioner on the City of Sonora Planning Commission.

BACKGROUND:

On July 1, 2018, the term of Commissioner Ron Jensen will expire. Each Planning Commissioner serves a 4-year term and Ron is completing his second term. Notice of the pending vacancy was published in the Union Democrat on April 11, 2018. Those interested in serving on the Planning Commission were instructed to submit an Application on or before May 11, 2018. The Mayor received only one application for the position and that was from Ron Jensen, a copy is attached.

DISCUSSION:

Based upon the information provided, City Staff recommends that the Mayor exercise her prescribed duties, with approval from City Council Members, to make the abovementioned appointment to the City of Sonora Planning Commission, effective July 1, 2018.


