RE: SPECIAL OLYMPICS TORCH RUN

RECOMMENDATION:

It is recommended that the City Council approve the Special Event permit application to allow the temporary rolling closure of Washington Street and Stockton Road from the Red Church to the Mother Lode Fairgrounds on June 16, 2017 to accommodate Special Olympics Torch Run.

DISCUSSION:

Attached is a Special Event application submitted by Officer Faustino Pulido of the California Highway Patrol requesting the City's approval for the use of City streets for the Special Olympics Torch Run. This is a fundraising event for Special Olympics athletes.

The event is scheduled on June 16, 2018 between the hours of 9:30 AM and Noon, inclusive of set up and take down. The event will begin at 10:00 AM and include a run/procession from the Red Church to the Mother Lode Fairgrounds. The participants will be escorted en masse with lead and follow cars by the California Highway Patrol utilizing the southbound lane of Highway 49. Caltrans has reviewed this request and is not requiring any traffic control devices, signs or additional traffic control.
