Case(s) for Discussion:

On February 8, 2019, at around 8:30pm, a reckless driver that collided with a guard rail was reported in the area of Mono way and Hospital Rd. When officers arrived they located a Hyundai sedan stopped in the middle of the roadway with the driver's door open, the vehicle was left running and no driver was near. The male driver, later identified as Jack Martin of Sonora, left the scene after removing a 4-year-old child from the front seat. The child was later passed a motorist driving by the scene. Martin then ran across the roadway and jumped the railing on Mono way down to Hospital Rd and fled the area. With mutual aid from CHP Sonora and Tuolumne County Sheriff, Martin was later located and arrested and booked into the Tuolumne County Jail for felony Child Endangerment, Driving Under the Influence of Drugs and causing a Hit and Run accident. Thankfully the child was not injured and was turned over to a family member. Martin is facing a twelve year prison term per the Tuolumne County District Attorney filling the charges.

On February 13, 2019, Sonora Police was contacted by Sonora Lumber about a male that had stolen items from their store; one of the items was a Yeti Tundra Cooler. Approximately \$1,000.00 worth of other items had been taken. The male, later identified as Joseph Rizzuto of Sonora, was seen in the area. He was located and booked for Felony Grand Theft, Petty Theft, two felony Warrants and five misdemeanor Warrants. It was also determined that Rizzuto had taken several items from Sonora Lumber and Calaveras Lumber since the beginning of February.

Training:

- > Officer Brickley finished the Basic Police Academy and is now working on the Field Training Program with the Sonora Police Department.
- > Officer's Carrasco, Olson and Brickley attended DRAGER training mid February at Ripon DOJ Lab. They are now qualified to use the DRAGER alcohol test machine.

Explorers and Community Service Volunteers:

- > Both the Explorers and Community Service Volunteers provide great service to our agency and the community. They have put in hundreds of hours of volunteer time for the Police Department.
- > The Explorers had two meetings this month and one parking detail.

Contract/Reserve Officers:

- > Reserve Officer Danny Duffy is the Field Training Program.
- > We are currently reviewing an application for a Reserve Officer applicant.
- > Officer Townsend continues to work numerous patrol shifts each week to supplement vacant positions and open shifts.

Dispatch:

> We have one part-time Dispatch position open. No one is in the CTO Training Program at this time.

Defensive Tactics Program:

> Officer Brandow has been scheduled for a weaponless defense instructor course in the near future.

Kish was located a short distance away from the bar and was taken into custody. He was intoxicated, and was later booked into the Tuolumne County Jail for felony assault, battery, and vandalism.

19-155. On Sunday evening, February 3, 2019, Eric Shirley, 29 of Modesto, was arrested for battery with serious injury. Shirley got into a fight with an acquaintance at his apartment, and caused two lacerations and severe swelling to the face of the victim. The victim was transported to AHS for treatment. Shirley was located a short time later and arrested. He was booked into the Tuolumne County Jail for felony battery.
